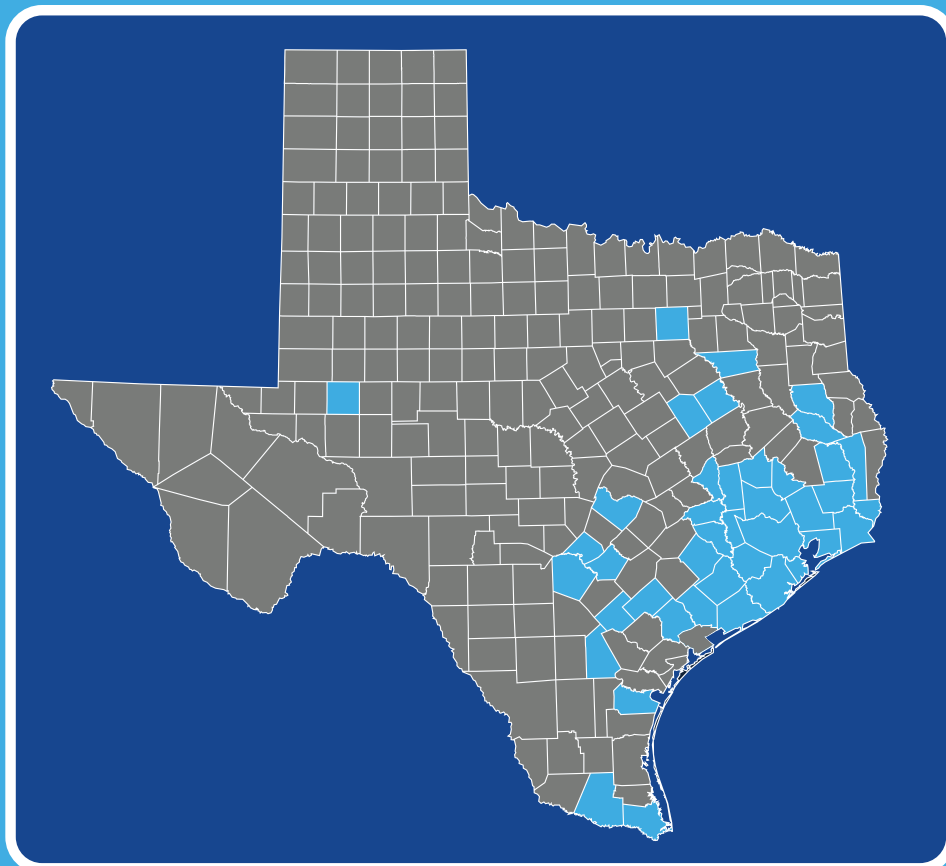

Vania's Story

Our daughter Vania was diagnosed with hearing loss before her first birthday because of a rare genetic disorder. Initially, this was a devastating diagnosis for us. Then we learned about Texas Hearing Institute through mutual friends and immediately scheduled an appointment. The expertise of the Pediatric Audiologists helped guide Vania and us through getting a diagnosis, receiving bilateral cochlear implants, and providing several years of speech language therapy through the Melinda Webb School.

Today, Vania is in 7th grade at Cornerstone Middle School, taking not only mainstream classes, but making honor roll each semester, acting as stage manager for the theatre tech department and serving in student council – none of which would have been possible without the help, guidance and expertise from Texas Hearing Institute. We are forever grateful for all that they've done, and continue to do for kids like Vania.

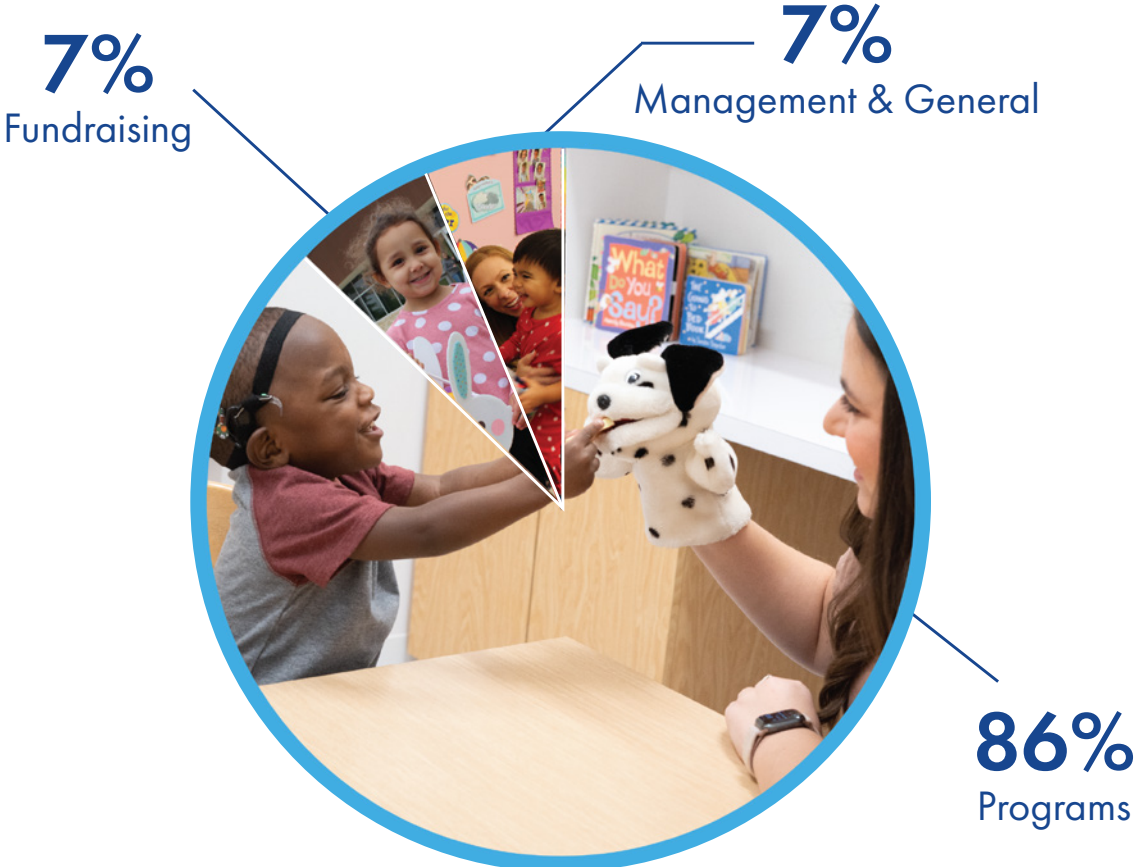
